## A RESOLUTION FOR THE CITY OF BUCHANAN, COUNTY OF BERRIEN, MICHIGAN TO ADOPT BUDGET AMENDMENTS FOR THE CITY OF BUCHANAN FOR FISCAL YEAR 2020-2021
