## **RULES AND REGULATIONS**

- 1. User shall not damage or remove property of any sort from the shelter.
- 2. NO littering

3. NO animals are allowed to run loose or be tied to any trees or plants. User must pick up after pets.

- 4. NO hunting
- 5. NO open fires
- 6. NO glass containers
- 7. Alcoholic beverages are subject to State and City approval.
- 8. NO parking or driving vehicles in other than designated areas
- 9. **NO** reckless use of bicycles
- 10. **NO** weapons or firearms
- 12. NO swimming or wading in creek (Centennial Park, Duck Pond)

13. Due to riparian rights and the delicate ecosystem of McCoy's Creek, no mowing is allowed within 10 feet on either side of the creek (Centennial Park, Duck Pond)

- 14. All users must take and dispose of their own garbage. No garbage is to be left on the premises
- 1. If premises are not left in a satisfactory state, an additional bill of \$150 plus cost of repairs will be billed.

15. Applicant agrees to ensure that its guests, members, invitees, staff, representatives during set-up, use, and tear down and all times in between follow and comply with all laws and regulations, including local, County, State and Federal relating to any and all health-related mandates. This shall include, but is no way limited to: following occupancy restrictions, social distancing and wearing of masks or other face shielding as required or as advised and to provide sanitizer/disinfectant stations for whatever the most recent county or state health mandate may be.

## AGREEMENT

It is agreed by the undersigned that the organization and/or individual will waive and hold the City of Buchanan harmless of and from any and all loss, damage, or injury which it might sustain or become liable for, to any persons whatsoever, or property arising from any cause if for any reason in and about, during, and because of the use of facilities.
